Scotland Update

Since our last Retired Lines, we have had new developments surrounding the proposed merger of British Transport Police (Scotland)

As our Chairman has written in this edition, a change of Justice Minister took place in the summer. It was announced that the new Minister wished to put the merger on hold, in order to obtain further views from stakeholders.

It should be noted, at this stage this is a postponement and not a cancellation. However, in the short term (Whatever the short term is?) the merger is off.

NARBTPO were then invited to a Scottish Government meeting, held to explore accountability and responsibility in the delivery of railway policing in Scotland.

This meeting was held on 6th November in Edinburgh.

Also in attendance were Academics, Rail Unions, Industry partners, the Chief Constable, the Chair of the BTP and Scottish Police Authority members, Dept of Transport, Her Majesties Inspectorate of Constabulary (Scotland) The BTP Federation and TSSA.

We had an opportunity to pose questions to Mr Humza Yousaf, Cabinet Secretary for Justice. This was the first time we had met him, and we can report back that he is fully aware of the pension issues.

He is open to hearing from stakeholders and was genuinely constructive, but firm on the fact this merger could still go ahead if we do not supply solutions.

This meeting was held over a full day and was intense in its content.

The tone was different to those we have previously attended, as the focus was solely to examine and explore how B.T.P. might become more accountable to the Scottish Government. It did not specifically cover pensions, but we did raise this with the Minister.

No decisions were made but we hope to hear more, once the powers have reflected on the day, by Christmas.
